A. <u>Action status & general overview of next 2 years</u>

a) Action overall

i. Budget

The Chair reviewed Action spending in Grant Period 1 (GP 1) and the remaining budget of GP 2 (2015).

Spending

A fairly significant portion of the GP1 budget was not spent (approx. 18 000€). This is due to the difficulty of calculating accurate expenditure estimations for large meetings (e.g. variation in travel costs and last-minute cancellations).

 \rightarrow Since the Chatham meeting was held late in the first Grant Period, there was no flexibility time-wise to redirect the unspent funds from that meeting to other activities.

To make the most of this year's and future budgets, the recommendations are to:

- 1. Plan to have larger meetings earlier in the GP (= earlier in the year)
- 2. Have early deadlines for meeting registration
- 3. Process the TRRs from meetings quickly, especially meetings held in the second half of the year
- 4. Ensure the Action has activities in reserve that can be implemented easily and quickly at the end of a GP (that can potentially be transferred to the next GP)
 - Examples: STSMs, small task-oriented meetings (that can include more than one WG; henceforth called "Task Group Meetings"), dissemination (such as printing costs)

Current GP

Activities still planned for this GP are:

- WG2 Conference in Bucharest
- STSMs (approx 6)
- Reserve activities: Task Group Meeting(s)

Budgets in GP 3 and GP 4

No information is yet available from Brussels on the budget of upcoming GPs. The COST Association has, however, warned all Actions that COST may be facing budget cuts of approx. 7 %.

ii. Eva-Mayr-Stihl Stiftung (Stiftung = Foundation)

Gero informed the SG that the management and administrative tasks of the Action are too extensive to be covered solely by the funds from the Financial Scientific and Administrative Coordination (FSAC).

He was able to secure financial support from the Eva-Mayr-Stihl Stiftung and invested these funds into the Action management and administration since the beginning of the Action.

To acknowledge this support, a logo and brief information has been added to the website.

iii. Overall Action deliverables

<u>Capacity building and networking</u>: are considered successful thus far; any improvements possible will be strived for in the future.

<u>Identify & list coppice-relevant European institutions:</u> This has been done in terms of a list of EuroCoppice members on the website. It is also a task of WG1 (see below) and will be added to the website once it's been further developed.

<u>Platform for networking and interactive cooperation:</u> are also considered successful thus far; the main contributors are the website, meetings/conferences, TSs and STSMs.

<u>Website:</u> The website is running and is continuously updated.

<u>Promote establishment of an international working group on coppice forests hosted by IUFRO:</u> This began in Salt-Lake City and will be continued by the Chair.

<u>Coppice Policy Paper</u>: The Policy Paper is connected to all WGs, particularly WG 5, and will be based on data and experience gained during the Action.

b) Each WG (Work Plan)

The current status of all WG deliverables (as listed in the MoU Work Plans) can be found Progress Report, which was submitted by the Chair to the Scientific Officer on April 30th, 2015. Following external evaluation, the Progress Report will be published by COST. Thus, not all details of Deliverable will be repeated here.

Note: The Deliverables are based on the Work Plans of the respective WG in the MoU

WG 1 Deliverables – Dagnija

Comments on Deliverables:

- <u>Del 1</u> Definitions: Has begun; resulted in responses from 22 countries, a second inquiry email for rough statistical data and updates will be sent soon
- <u>Del 2</u> Statistics: It was agreed that this can only be done on a "rough" level. The results will end up in the Factsheet.
- <u>Del 3</u> Expert List: Has begun, along with list of publications. Identified experts overlapping with International poplar expert list.

WG 2 Deliverables – Noro

Comments on Deliverables:

- <u>Del 2</u> Meaning of "collect knowledge which may not yet have been published": This refers to an "oral history" or, in other words, a "collection of stories" related to common (historical) views on coppice in different countries/regions OR information from unpublished Bachelor/Master Theses etc. It is not meant to be comprehensive, but rather add "spice" to facts and figures.
- <u>Del 5</u> Typology: should be done quickly and should avoid overlap with WG1 (or potentially WG5). It provides a basis for Del 6.
- <u>Del 6</u> Best Practice Handbook: should be developed in cooperation with WG3, who also have a Best Practice Handbook deliverable. The structure and Table of Contents etc. should be done soon so that there's a clear idea of what needs to be done and by whom until the end of the Action.
- Dissemination: details have been given to Alicia
- <u>Other</u>: Noro and Patrick Pyttel have produced a booklet with 500 word summaries of 17 countries titled "Evolution and perspectives of coppice forests in some European countries and South Africa". Debbie offered to assist with the proofreading of the document and will write a contribution for the UK.

WG 3 Deliverables - Raffaele (on behalf of Natascia)

Comments on Deliverables:

- <u>Del 1 &2</u> Traditional & new products: these two Dels are connected and have begun. A draft will be presented in Bucharest
- (Del 3 Remote Sensing: cancelled due to lack of resources, see Chatham meeting)
- <u>Del 4 & 5</u> Harvesting methods & benchmarks: Data from published and grey literature sources (in respective national language and internal reports) have been collected for multiple countries, including: Italy*, France*, Spain, UK, Portugal, Germany and Poland... (*Most extensive thus far). A meta-analysis is planned. Results from a preliminary statistical analysis will be discussed in Bucharest.
- <u>Del 6 –</u> Identify knowledge gaps: Begins in 2016
- <u>Del 7</u> Conference: Begins in 2017, see Conference point later in the Agenda
- <u>Del 8</u> Handbook: A Task Group will be set up with WG2
- <u>Dissemination</u>: There are 2 published articles with Impact Factor and 2 published without, posters etc. (Details have been given to Alicia)

WG 4 Deliverables – Christian (on behalf of Peter)

Comments on Deliverables:

- Del 1 & 2 Protection functions lit & legislations: The group is concentrating on coppice protection functions in steep terrain (erosion, rock falling...) and the emphasis is on literature rather than legislation. The two Dels are not defined very clearly and will be rephrased. It should then be clear that 1 is more technical and 2 is legislative (and 3 is general) and can include further specifics. In addition, the WG doesn't have the expertise for part of Del 2 and will contact WG3 for assistance. → These rephrased Deliverables will be presented to the MC in Bucharest for approval, providing that the Officer / COST Association is in agreement. The final report is planned for December 2015.
- <u>Del 3</u> Services: The group is mainly working on Natura 2000. There will be a presentation on the topic at the SISEF (Italian Society of Forest Systems and Ecology) conference in Italy this year (Sept. 16-19). The Directive Annexes (Species Lists) will be checked for those who could benefit from coppice. Florian will compile a report on SRC.
- <u>Del 4</u> Legal docs: This is connected to WG5 and somewhat to WG1.
- <u>Dissemination</u>: Book chapter and article, Life+ application, conferences (Details have been given to Alicia)

WG 5 Deliverables - Debbie

Comments on Deliverables:

- The Deliverables have been rephrased in plain English:
 - 1. To identify governance issues influencing coppice management, particularly with respect to ownership and access
 - 2. Explore the interaction(s) between small scale forestry and coppice management
 - 3. To identify barriers to the development of the coppice business sector, particularly with respect to traditional practices in the current legislative context
 - 4. Explore potential ways to overcome barriers and promote development in the small scale coppice forestry sector
- → These rephrased Deliverables were agreed upon by those present at the SG Meeting and will be proposed to the MC in Bucharest for approval, providing that the Officer / COST Association is in agreement. Further modifications to the rephrasing may take place beforehand if deemed necessary by WG5. The WG has had some difficulty grasping the meaning of the Deliverable and direction the WG should take. It was also commented that the topic is not very clear to the rest of the Action. Debbie will thus develop a short summary/review on coppice governance for distribution.

b) Meeting/Conference attendance reimbursement

It had become apparent prior to the SG meeting that an exact procedure for identifying participants to be reimbursed for attending a WG Meeting or Conference was needed. This procedure is first and foremost required to adhere to COST Rules (which can be found in the Vademecum). Secondly, within the framework of these rules, the objective is to have a balanced group of competent and engaged Action Members attending. Being such a large Action, with so many scientists from so many different countries, deciding on who is authorised to make this selection of WG Members to be reimbursed is a challenge. The SG endeavoured to find a procedure that takes the COST Rules and MOU Objectives into account, draws on the competencies of the MC and is feasible from an administrative point of view.

After a long discussion and with the notable opposition of Raffaele Spinelli, who advocated a stronger (decisive) role of the National MC delegates in the selection of National experts to the WGs, the SG agreed on the procedure below for the selection of participants eligible to be reimbursed for a WG Meeting or a Conference.

<u>Note 1</u>: To be eligible for reimbursement, the participant must belong to a Working Group (see "Nomination to a WG" above).

Note 2: This procedure does not pertain to MC Meeting, to which all MC Members are invited.

<u>Definition of Early Career Investigators (ECI):</u> "A researcher within a time span of up to 8 years from the date they obtained their PhD/doctorate (full-time equivalent)." (In some Action definitions, those at the end of their PhD are also included.)

<u>Definition of young researchers</u>: These are not necessarily ECIs (see previous) and are also mentioned explicitly, but not clearly defined.

<u>Eligibility:</u>	
Meetings:	no specific rules other than the above
STSMs:	must be a PhD student *OR* have completed a PhD < 8 years prior to applying (ECI)
Training School:	must have at least a Bachelor; the TS call can define further criteria

f) STSMs - Pieter

- <u>Rules</u>: There are new COST rules and guidelines for STSMs
 The pdf with application instructions on the Action website has been updated
- <u>Quality</u>: There is much room for improvement in the quality of STSM applications and reports. Pieter (as STSM Coordinator) will reject all future applications that do not have a connection to the MoU (rather than send them to the SG to vote).
- <u>Report</u>: Often the report cannot be accepted right away and there is no (clear) description as to what was actually done during the STSM (it is rather closer to a literature review).

<u>Focus</u>: The SG recommends focussing the STSMs more on the Deliverables of the Action
 STSM topics will be offered on the website as a sort of "billboard". However, it should be highlighted that freelance application on another topic is still possible.

 \rightarrow WG Leader will work more closely with Pieter on the evaluation of STSM applications and reports on subjects relevant to their respective WG

- <u>Format</u>: The format of "first-come-first-serve" will be kept as it is. All applications are sent by Pieter also to Enrico without comment to be evaluated; thus far, Pieter and Enrico have shared the same view of each application.
- <u>Application Deadline 2015</u>: Incoming requests will be accepted until Sept. 15th. The Chair will propose the MC to transfer any leftover funds to a Task Group Meeting.
- <u>Application formalities:</u> Any changes to an application means that it must be resubmitted in e-COST. Thus, all applicants should read the info on the website in detail before applying.

WG4 Conference 2016

Planning is in progress for a Conference in Belgium, to be hosted and organised at the University of Antwerp by Reinhart Ceulemans & Stefan Vanbevern, with input from Kris Verheyen (Ghent University). A preliminary plan for the conference (developed by Peter and the organisation team) was presented.

The SG made the following comments & recommendations:

- <u>Dates</u>: 15-17.06.2016 were deemed good dates for the conference (there is a competing conference by the KWF the 8-10.06, Gero and others would not be able to attend then)
- <u>Number of reimbursed Action participants</u>: 70-80; depends on GP3 budget, may have to be less.
- <u>Invited Speakers</u>: up to 2 invited speakers can be reimbursed through the Action (pending approval by the MC). This should be reserved for keynote speakers.
- <u>Length</u>: a 1-day (as opposed to 1.5 day) conference was supported, especially in order to be more attractive to those from outside of the Action. It was thought that presentations should last 20 min (including discussion) and that 30 min presentations are too long.
- <u>Timeline</u>: 3 full days;
 - \circ Wed \rightarrow WG meetings 9-12 and 13-16:00, MC Meeting 16-17:30, 17:30 Conf. registration
 - Thurs \rightarrow Conference (whole day)
 - Fri \rightarrow Excursion (whole day)
- <u>Topic</u>: The WG4 topic has priority for the Conference, but it is important to have cross-sectional relevance, allowing insights from other WGs (e.g. harvesting/silviculture/governance + protection). Examples of technical subjects are the environmental impact of harvesting techniques and, conversely, the impact of environmental restrictions on the financial sustainability of harvesting operations. → The Conference organisers are requested to include *at least* 2 presentations on cross-sectional topics, which are to be presented in plenum.
- <u>Conference Format</u>: It was considered important to have at least some presentations in plenum (see "Topic" above). Possible options could thus be Plenum-Parallel-Plenum, or Plenum-Parallel.
- <u>Scientific Committee</u>: Debbie volunteers to be on the scientific committee
